1. Elections

1a. Election of Chair

JC was elected to be Chair and all the councillors voted in favour.

3. Declarations of Interest

No interests were declared.

4. Minutes of last meetings held on 3rd April and 2nd May 2012

The minutes were both agreed and signed as a true record of the meeting.

5. Matters Arising from the previous meeting

Registration of Swalcliffe Common - Ongoing.

Removal of Tree by the Old Bakehouse by Fountains - The tree is to be removed in the next week or two.

Speedwatch - To carry forward to the next meeting.

Capping of wall around the Green - The work has been done.

White gates to mark entrance to the village - Peter Egawhary of OCC Highways has advised that they have now received this years financial years maintenance budget and he is hoping to re-'kick start' the order for the white gates.

Undergrowth in churchyard - MT to spray again.

Childrens Play Area - The Chair had attended a meeting with the trustees of Oxford Buildings Trust and she put the idea to them. They asked for the Parish Council to put a proposal together for it to be presented to the Board of Trustees at their next meeting on 2nd July. The Chair has asked Rob West if he can help with the plans. On the day of the meeting the car park was full of cars which is an issue if there is to be a children's play area close by. Some felt this area is still too close to the Main Road but others felt it would be a place for families to meet up. The councillors then discussed the piece of land in front of the school which is not registered. It is village land and should be registered.

Action: The Parish Clerk to look at registering the area.

Common clearing - The area has been sprayed.

Planning Application 12/00194/F, Demolish existing outbuilding and associated shed and greenhouse, construct new 3 bedroom cottage at Lime Tree House, Main Road. Approved by CDC.

Planning Application 12/00207/F and 12/00208/LB, Refurbishment and internal reordering of the first and second floors of main boarding house and two new rooflights and an extended dormer to rear of Swalcliffe Park School, Green Lane. Approved by CDC.

Plant for wellhead - MS to buy.

Broadband Exchange - Residents have registered their interest.

Diamond Jubilee - Cllr Foley has ordered the jubilee mugs and the cost is £262.50. There will be a tea party for the children at 12.30pm on 3rd June. The Chair has asked Virginia and Peter if the tea party can be held in their garden. The Parish Council agreed to pay for the pig roast, exact figures not known yet but approximately £100.00. The barbecue food to be served at 2pm. Cllr Foley to book the village hall in case the weather is bad.

Action: The Chair to design and send out RSVP party invitations for the children's jubilee lunch party and to publise the pig roast. Cllr Foley to speak to the pub and change the day of the barbecue to 3^{rd} , not 2^{nd} .

Planning application 12/00387/F, for Fairview Cottage, Main Road - The Parish Council objected to the west wall, facing the neighbor and visible from the street being rendered. Cllr Bradshaw noted that although objections should be planning based, it is not the role of the Parish Council to look at each application and consider its merit against all of the planning rules - that is for the planners. If an objection is raised by the Parish Council, it is done so because the Parish Council feels it affects the village. Only then do the Parish Council consider whether they have a true planning reason for objecting.

Parish Pit - Cllr Bradshaw confirmed that the council needs to check they are adequately insured.

Action: Parish Clerk to check the insurance policy.

6. To review and discuss the general planning procedure of the council
